Craft Vendor Agreement for 32nd Annual Billtown Blues Festival

Friday June 10th ~5-10p; Saturday June 11th ~12n-10:30p; Sunday June 12th ~11am- ~5pm

NOTE THREE DAY FESTIVAL Friday, Saturday & Sunday, June 10, 11, 12, 2022

- 1. VENDOR FEES:** Craft vendor will pay **\$100** to the Billtown Blues Association (BBA). This includes vendor space to the event for all three days and for one person (the vendor). Review pricing form below for all vending options and check off what you prefer. Vendor Assistant tickets are **\$70** for all three days.
- 2. SPACE:** The BBA will provide a space on the grounds of the Lycoming County Fairgrounds for the vendor to setup their tent(s) and merchandise. The space size is a generous 10'x 10' with ample room between vendor spaces. Double and Triple spaces can be reserved for \$200 and \$300 respectively, if ordered on or before the registration deadline, May 15th, and as space permits.
- 3. SETUP:** Fairground access for set-up is **Friday June 10th at 2pm**. All pre-registered vendors will have received a packet by mail with your craft vending "ticket" indicating you have pre-registered. You will receive a parking pass required by security. Your name and craft name will also be on a list at the security/entrance gate. Setup for Sat arrivals is 10am, and Sun arrivals is 9am.
- 4. UPON ARRIVAL:** A BBA volunteer will direct you to the next available location. You will receive a wrist band, and your vending ticket will be collected. Any Vendor assistant tickets ordered in advance will be in your packet to distribute and will be processed the same way if they arrive with you. Should they come separately, later, or in shifts throughout the weekend, they will park in general parking, come to the main entrance gate where they will be wrist banded (each day) and proceed to your vending area. Everyone with a wrist band can come and go throughout the event. A new wrist band color will be required each day. Earlier Friday set up times are available by request, but only during times our work crew is there. The grounds are locked otherwise. Your request should be made 1 week in advance of the Festival date. One vehicle is permitted at each vending space.

- 6. TENTS and TABLES:** Each vendor must provide their own protective tent and equipment including tables. Vendors cannot use any space under the BBA festival tents.
- 7. POWER:** We are permitting quiet (<70 DBa) running generators for evening lighting and sales or any other power needs. There are a few electrical outlets on poles in the craft and food vending areas, but a substantially long extension cord would be needed to insure access. We are directing all foot traffic from the camping area through a path in the craft vending area (good for you!)...so you need to be cautious about any cords in that walking area as a tripping hazard.
- 8. ONE MERCH RESTRICTION:** We are prohibited by artist contracts to sell any CDS by the Festival performing artists, as they are selling their own merchandise.
- 9. FOOD PRODUCTS:** Food intended to be consumed onsite, not pre-packaged (like jars of homemade relish for example), are prohibited to be sold by craft vendors. If you are interested in selling food to serve the attending patrons, you would need to contact Dave Strickler at 570-220-0077 or dbstrick64@gmail.com and discuss the information pertaining to **FOOD VENDORS**. Certificates of insurance and other documentation would be required and the set-up procedure and area is different.
- 10. VENDOR LODGING:** Lodging for the weekend is available in the onsite camping area. Over-nite lodging in the craft and/or food vending areas **is not permitted** for security reasons. The vending/music grounds are locked with no access after the conclusion of each day's music. The vendor assumes full responsibility for any weather (wind/rain, etc) damage, or theft, of unattended merchandise, but you may leave your protected merchandise set up in the vending area each nite assuming full responsibility.
- 11. ALTERNATE ONSITE LODGING OPTIONS:** CAMPER/RV and CAR/TENT Camping is available for a minimal overnight lodging fee. Refer to options and pricing below, and **review all lodging detail at billtownblues.org**

OUR CAMPING AREA IS RESTRICTED TO PUBLIC ACCESS. LODGING TICKETS INCLUDE MUSIC SPACE ACCESS FOR ALL THREE DAYS; SHOWERS, "REAL" RESTROOMS, AND FOR CAMPES/RVs, ELECTRIC AND WATER HOOK-UPS. KIDS UNDER 16 ARE OUR GUESTS.
